

## REGULATION

CINANIMA On Tour is a segment of CINANIMA - International Animated Film Festival of Espinho which aims to disseminate the author's animation cinema, in the period following each annual edition of the Festival, which takes place in November. The proposals of CINANIMA On Tour are available from January 15th to June 30th.

### TARGET AUDIENCE

Any entity/institution that wishes to exhibit the programme(s) and subscribes according to the terms proposed by CINANIMA On Tour.

### COSTS

- AWARDED 2024 – 70 min (1 screening) - 150 euros
- Pack CINANIMA On Tour + CINANIMA Junior – 200 euros

Note 1. For each additional exhibition add 50 euros.

Note 2. The prices established do not reflect a commercial interest; they only cover the costs of the film exhibition rights to be paid by CINANIMA to its owners.

### HOW TO PROCEED TO REQUEST THE PROGRAMME

Fill out the Online Form – Registration, Declaration and Payment at [cinanima.pt/en/extensions/cinanima-on-tour/](http://cinanima.pt/en/extensions/cinanima-on-tour/). The request must be made at least 20 days before the film screening date. After filling in the form, the payment must be made by bank transfer.

### REPLY FROM CINANIMA On Tour

After the confirmation of the payment, the authorization for the exhibition of the films and the link to access the files with the films of the Programme(s) will be sent by e-mail.

## COMMITMENTS AND OBLIGATIONS

1. The institutions that request any of the available Programmes must exhibit them to the public of the age range indicated in them.
2. It is expressly forbidden to charge a ticket or any other sum to the public attending any of the Programmes.
3. The institutions that request the programme(s) undertake to communicate, via e-mail, within working days from the date of the last screening session, the number of spectators per session, accompanied by photographs, for the purposes of official statistics.
4. The exhibition of any of the available programmes runs from 15 January 2024 to 30 June 2025.
5. The exhibition of the assigned films is authorised only for the dates provided for in this agreement and not for other later dates.
6. The entity authorised to proceed with the screening of the films commits to mention, in all internal and external communication means, the following mention: "In collaboration with CINANIMA - International Animated Film Festival of Espinho - CINANIMA On Tour", using, namely, the communication materials for this effect (poster and room sheet – technical file).
7. The exhibition of the hired programme/s is conditioned to the full accomplishment of this Regulation.

9. Any situations that are not covered by these Regulations will be decided by those responsible for CINANIMA on Tour.
